

# Frequently Asked Questions

## eNWR Revalidation

**eNWR Revalidation** is the periodic process of assaying / testing of stored commodities in a Warehouse to keep consistent record of quality and quantity of the commodities stored with a Warehousemen. This is usually done within the storage period of the commodity.

### 1. Can eNWR (electronic Negotiable Warehouse Receipt) be revalidated?

Yes. eNWRs can be revalidated.

### 2. When can I revalidate my eNWR?

eNWR will be available for Revalidation 15 days prior to initial / next validity date and 15 days after the initial / next validity date

E.g. A Depositor Deposits his/her commodity, Wheat, with a Warehousemen on 1<sup>st</sup> January and the initial validity of the eNWR is 30<sup>th</sup> June, then respective eNWR will be available from 15<sup>th</sup> June to 15<sup>th</sup> July for Revalidation.

### 3. What entails in the Revalidation Process?

The Client / Pledgee can inform the Warehousemen to initiate the Revalidation process. Once initiated, the Assayer will conduct the tests and input the test results into the Repository system. Post this, the eNWR gets updated.

### 4. What if commodity doesn't adhere with AGMARK standards during revalidation?

All commodities stored in WDRA registered warehouses, by default, have to adhere with the AGMARK/BIS standards. In case, the commodity fails to do so during the revalidation

process, the eNWR gets converted to a eWR (electronic Warehouse Receipt) and becomes available only for withdrawal transactions.

## 5. What are the charges for the revalidation levied by Warehousemen?

The Charges for Revalidation are mutually agreed upon between the Client himself and the Warehousemen before getting into an agreement. The same is later added to the Client – Warehousemen Agreement.

## 6. What are the charges for revalidation levied by NERL?

NERL charges for revalidation transaction is Rs 10 / MT. For more details kindly refer NERL circular no NERL/OPERATIONS-011/2020/020 dated June 18, 2020 on Transaction charges on extension/Revalidation of eNWR.

## 7. Is revalidation mandatory?

Yes. Revalidation is mandatory for eNWR.

## 8. What if commodity is not revaluated?

If the commodity is not revaluated within the stipulated time, then eNWR won't be for any transaction other than Pledge release, Pledge invoke and withdrawal.

## 9. Is shelf life / revalidation date fixed for eNWR?

The shelf-life and its initial / subsequent validity date varies across Warehouseman's. However, WDRA has prescribed a commodity-level validity structure which should be adhered to by registered Warehouseman's. ## 10. Is there any grievance redressal in case of disagreement with the test results of revalidation?

In case of any conflict or grievance regarding the revalidation process, the Client can reach out to the WDRA Grievance Redressal System which is also available online.

**11. How does revalidation affect pledged commodity?**

Pledged commodity can be revalidated, commodity will remain as pledged in favor of pledgee however it will be available for Revalidation to Warehousemen / Assayer. Post Revalidation if commodity complies with the AGMARK norms than the commodity will continue as pledged – eNWR, but if the commodity fails in AGMARK norms than commodity will be converted to eWR in pledged state which will be available for pledge release and pledge invoke and later can be withdrawn.

**12. Where can I check the Revalidation details?**

Refer “Revalidation Report” report available under Report section in your login.

**13. Where can I check the list of eNWRs that are due for Revalidation?**

Refer “Due for Revalidation” report available under Report section in your login.

**14. Can an eNWR that is partially withdrawn be revalidated?**

No, balance quantity and withdrawn quantity both won't be available for Revalidation.

**15. Can an eNWR that is partially pledged be revalidated?**

No, for making eNWR eligible for revalidation entire quantity should be with single beneficiary and in pledged or free state.

**16. Can an eNWR that is partially transferred via ownership transfer transaction be revalidated?**

No, for making eNWR eligible for revalidation entire quantity should be with single beneficiary and in pledged or free state.

**17. Where can I check the grade and parameter values of eNWR after revalidation?**

Revalidation report or printable format of eNWR can be referred to check the grade and parameter value after revalidation.

**18. What does initial Validity date means?**

Validity provided at the time of deposit, on which the eNWR will be revalidated is known as initial validity.

**19. What does number of extension means?**

Number of times a eNWR can be extended upto shelf life is known as extensions.

**20. Will eNWR be available for Revalidation if the eNWR is locked in any transaction?**

No, for making eNWR eligible for revalidation entire quantity should be with single beneficiary and in pledged or free state.

**21. What is the transaction flow of Revalidation transaction?**

Transaction flow of Revalidation is same as Deposit transaction i.e. Warehouseman maker → Warehouseman checker → Assayer maker → Assayer checker → Warehouseman checker.

**22. Will I receive any alert after revalidation?**

Yes, on successful completion of revalidation transaction SMS and Email will be received on registered mobile number and email id.

**23. What is the impact of warehouse status on Revalidation transaction?**

eNWRs in warehouses with status other than “SURRENDERED” will be eligible for revalidation.
